The EU regulation No 1227/2011 about the integrity and transparency of wholesale energy markets (**REMIT**) sets out binding reporting requirements for market participants of electricity and gas markets:

- transactions data (for contracts)
  - standard contracts of stock market (notifiable since 07.10.2015)
  - off-broad special contracts (notifiable since 07.04.2016)
- fundamental data (for plants)
  - production and storage capacity
  - consumption
  - transmission and transport capacity

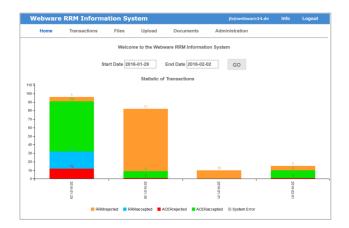
For these transactions strict demands are made in relation to

- timely reporting,
- file format and
- documentation of data transfer.

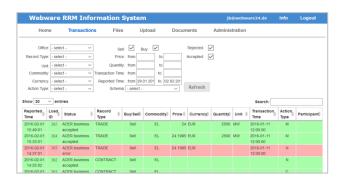
In most cases a registration at the German Federal Network Agency is required, which reports the data to the Agency for the Cooperation of Energy Regulators (ACER). Following companies may be subject to registration:

- energy producers
- transmission system operators
- distribution system operators
- consumer

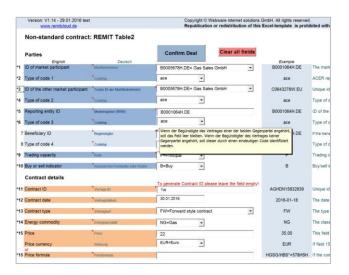
